## THE MAGIC MILLIONS RACE SERIES

All yearlings listed in any Magic Millions Catalogue which subsequently become offered and/or sold will have the right to qualify for the Magic Millions Race Series commencing in December 2010 providing such yearling/s are formally nominated in the prescribed manner and in accordance with and subject to the following Conditions of Entry.

Subject to restrictions as to age, sex and, in some instances performance, all yearlings which have been offered at any/all Auction Sales conducted by Magic Millions Sales Pty Limited (ABN 54 078 396 317), Magic Millions Sales Partnership (ABN 99 519 379 694) or Australian National Weanling Sales Pty Ltd (ABN 50 063 859 218) and organised and promoted by Magic Millions Promotions Pty Limited (ABN 41 088 197 200), plus any other Sale as might be specified in relation to the race event to be conducted in Malaysia to which separate Conditions of Entry apply, will have the right to qualify for the Magic Millions Race Series.

The Magic Millions Race Series conducted in Australia, will be held in the States of Queensland, South Australia, Western Australia and New South Wales commencing in December 2010.

**NOTE:** The date, distance, venue and prizemoney of each race in the Magic Millions Race Series will be advised on the Official Nomination Form and may be subject to change.

**EACH** Nomination together with the Nomination Fee for each horse, must be paid to Magic Millions Promotions Pty Limited within 42 days of the date of purchase of the horse, to retain your horse's right to qualify for ALL races conducted in Australia.

### A. RIGHT TO QUALIFY AND EXERCISE OF RIGHT TO QUALIFY

#### 1 Right to Qualify for Magic Millions Race Series

- 1.1 Subject to restrictions as to age, sex and, in some instances performance, all yearlings which have been offered at any/all Auction Sales conducted by Magic Millions Sales Pty Limited (ABN 54 078 396 317), Magic Millions Sales Partnership (ABN 99 519 379 694) or Australian National Weanling Sales Pty Ltd (ABN 50 063 859 218) and organised and promoted by Magic Millions Promotions Pty Limited (ABN 41 088 197 200), plus any other Sale as might be specified in relation to the race event to be conducted in Malaysia to which separate Conditions of Entry apply, will have the right to qualify for the Magic Millions Race Series.
- 1.2 Following the offer of a yearling at a Sale referred to in 1.1, Magic Millions Promotions Pty Ltd grants the owner of that horse the right to have that horse qualify for the Magic Millions Race Series.
- 1.3 Any horse which is sold through any Yearling Sale other than those referred to in 1.1, will not have a right to qualify for the Magic Millions Race Series, regardless of its status prior to such Sale.

#### 2. Exercising Right to Qualify for Magic Millions Race Series

- 2.1 Following the offer of a yearling at a Sale referred to in 1.1, the Owner may exercise its right to have the horse qualify for the Magic Millions Race Series by lodging the Nomination, together with the prescribed Nomination Fee within 42 days as specified on the Nomination.
- 2.2 The Nomination, together with the prescribed Nomination Fee, must be lodged in the prescribed manner as directed by the Official Nomination Form obtainable from the offices of Magic Millions Promotions Pty Ltd or any of the participating Turf Clubs conducting the Magic Millions Race Series.
- 2.3 Any Nomination lodged for which the prescribed Nomination Fee remains outstanding at the close of business on the date specified on the Nomination will automatically become null and void and the Owner's right to have the horse qualify for the Magic Millions Race Series will be extinguished.

**NOTE:** Participation in the Magic Millions Race Series will be determined by the Conditions of Starting as specified for each race in the Magic Millions Race Series (as set forth by the participating Race Club) including the payment of any Nomination and Acceptance Fees involved.

### B. ACCEPTANCES

Provided the Owner has paid in full the original Race Series Nomination Fee as prescribed in the Nomination Form to Magic Millions Promotions Pty Limited, the Owner will, with respect to the Race Series and with respect to each horse that the Owner nominates for each Race in each Race Series, contact the Trainers Service Centre on Telephone: 1800 138 704 or Internet: [www.stableassist.net.au](http://www.stableassist.net.au) for all first acceptances and final acceptances.

Magic Millions will procure each participating Race Club to apply the moneys paid pursuant to the above towards additional administration costs relating to such payments and prize money for any race in the Race Series (without any obligation to apply it to prize money for the Race for which the payments are made) or the general benefit of thoroughbred racing in the absolute discretion of Magic Millions.

Final Acceptances whether by one payment on a specified date or more than one payment on various dates with the appropriate Final Acceptance Fees must be lodged in the prescribed manner no later than the advertised time and date/or dates before the scheduled date of the running of each race in the Magic Millions Race Series concerned.

When Final Acceptances have been lodged in accordance with these Conditions Of Entry, and the acceptor is not successful in securing a start date due to the Conditions of the Ballot, the Final Acceptance Fees only will be refunded. Refundable Fees will not be available until the First Friday after the running of each race in the Magic Millions Race Series from the relevant authority.

### C. WEIGHTS AND PENALTIES

Weights and penalties for the respective Magic Millions Races will be published in the Official Racing Calendar of each respective state in which the Magic Millions Races are held.

### D. CONDITIONS OF BALLOT

#### 1. 2YO and 3YO Magic Millions Races

The Final Fields will be limited to a maximum number of starters as determined by the Turf Clubs conducting each race in the Magic Millions Race Series. In the event that the number of Final Acceptors exceeds the maximum permitted number of starters, elimination will be according to the gross value of prizemoney won by each acceptor as supplied by the Victorian Racing Club's Racing Services Bureau. In determining prizemoney eligibility for each race in the Magic Millions Race Series, all bonus prizemoney and added stakes (eg Super VOBIS, QTIS, SABIS, Westspeed, FAMIS etc) will be deducted from the official prizemoney as supplied by the Victorian Racing Club's Racing Services Bureau. For horses with no prizemoney earned, usual conditions of ballot will apply.

#### 2. Other Races

The final fields will be limited to a maximum number of starters as determined by the Turf Clubs conducting each race in the Magic Millions Race Series. In the event that the number of final acceptors exceeds the maximum permitted number of starters, elimination will be at the discretion of the handicappers applicable to each Turf Club and each State.

### E. GENERAL CONDITIONS

The nomination of entries with the Conditions of Entry set out above will only be accepted by the Turf Clubs conducting the Races on the express understanding that the Owners and Trainers of such entries, at the time set down for the running of the Races, agree to be bound by the Australian Rules of Racing and the Conditions of Entry laid down from time to time by the Committees of the Turf Clubs conducting each race in the Magic Millions Race Series, and those Conditions set out in any Official Entry Form pertinent to each race in the Magic Millions Race Series published by the Turf Clubs conducting each race in the Magic Millions Race Series.

Should it be necessary to vary or amend the Conditions of Entry and Starting for the Races, all decisions shall be made by the Turf Club conducting each race in the Magic Millions Race Series and their decision/s shall be final and binding on all parties. Further, Magic Millions Promotions Pty Limited reserves the right to vary or amend the Conditions of Nomination in its absolute discretion, subject to law.

### F. PRIZEMONEY

The prizemoney for each race in the Magic Millions Race Series will be distributed on the following percentage basis:

All other Starters to share equally 18% of the total Advertised Prizemoney, subject to Magic Millions Promotions Pty Limited reserving the right to adjust the proportionate distribution referred to above in the event of less than a full field of runners accepting for a race in the Magic Millions Race Series but provided that in so adjusting Magic Millions Promotions Pty Limited has discussed such adjustment in good faith with the relevant Racing Club conducting such race in association with Magic Millions Promotions Pty Limited.

**NOTE:** Prizemoney on placings 1st to 4th are subject to normal Trainers and Jockeys percentage deductions.

### G. SPECIAL CLAUSE

Magic Millions Promotions Pty Ltd reserves the right to reject any Nomination or extend the time to lodge such nomination for the Magic Millions Race Series and to change the venue and date of any race in the Magic Millions Race Series in its absolute discretion.

### H. GST ON NOMINATIONS FOR THE MAGIC MILLIONS RACE SERIES

Under the Federal Government's Goods and Services Tax ("GST"), Magic Millions Promotions Pty Ltd is required to charge GST on Nominations for horses purchased at a Magic Millions Sale for entry into the Magic Millions Race Series.
